Under her leadership, Siemens Stiftung has undergone a strategic realignment. The nonprofit, international foundation is committed to sustainable social development. Together with people and communities, it opens opportunities to actively shape social and ecological transformation. The focus of its work is now on three key areas of action: Essential Services, Digitality, and Climate. The foundation aims to tackle challenges in these areas together and use them as opportunities for innovation and positive change. Through its hands-on project work, it promotes access and participation, strengthens future-oriented skills, and enables shared learning. In interdisciplinary collaboration, Siemens Stiftung combines local action with global perspectives to specifically support resilience, social cohesion, and regenerative practices.

As Managing Director of Bucerius Education GmbH at Bucerius Law School in Hamburg, she was responsible for the Executive Education, Conference Management and Consulting divisions from 2006 to 2011. Prior to that, she was Deputy Managing Director of the International Centre for Graduate Studies at the University of Hamburg.

Dr. Nina Smidt holds a doctorate in linguistics and cultural theory, with a dissertation on critical literary theory at the University of Hamburg. As a postdoctoral researcher, she was awarded scholarships at the School of Criticism and Theory at Cornell University, US, and Haifa University in Israel. She previously studied German, English, and Education at the University of Hamburg, Political and Cultural Studies at the University of Technology in Sydney and Business Administration and Economics at the European School of Management and Technology in Berlin. She has also participated in various executive and board development programs at Harvard Business School, Yale School of Management, Columbia Business School, and WHU / IESE.

She has authored numerous publications on the topics of education, sustainability, social inclusion and participation, post-colonialism, transatlantic relations, future trends, and entrepreneurship.
